



Adventure Geek – Terms & Conditions (Community, Walks & Events)

These Terms and Conditions apply to all bookings made with Julia Doherty, trading as Adventure Geek, of 61 Glen Avenue, Blisworth, Northants, NN7 3ED (“we”, “us”, “our”).

By making a booking with us, you agree to these Terms and Conditions. Please read them carefully before booking.

Adventure Geek is a community-based walking and social group offering guided events and experiences.

1. Booking & Contract

When you make a booking, you are making an offer to attend an event or experience. Your booking is confirmed once you receive confirmation from us. At this point, a contract is formed. If you are booking on behalf of others, you confirm you have permission to do so and accept these terms on their behalf. You must be 18 or over to book.

2. Club Membership

We offer monthly and annual memberships. Payments are taken upfront and may recur. Membership can be cancelled at any time, but no refunds are given for unused time. Access continues until the end of the billing period. We may suspend or cancel a membership if payments fail, or if we believe that conduct is not inline with our values.

3. Walks & Events

All events must be booked in advance. You are responsible for arriving on time, wearing suitable clothing, and being fit to participate. We may refuse participation if you are not suitably equipped or behave unsafely. No refunds are given for late arrival, unsuitable equipment, or personal circumstances.

4. Weekend Adventures

Adventure Geek provides guided experiences only. Accommodation, transport, and meals are not included unless stated. You are responsible for your own arrangements. We are not responsible for third-party bookings, travel delays, or accommodation issues. Deposits (if agreed) are non-refundable.

5. Cancellation Policy

Walks & Events: No refunds within 48 hours. Transfers may be offered at our discretion. Weekend Adventures: Sliding scale applies (up to 100% retained within 14 days). If we cancel, a full refund or alternative will be offered.

6. Merchandise

Items are non-refundable unless faulty or not as described.

7. Digital Products

All downloadable purchases are non-refundable once accessed or downloaded.

8. Pricing & Payments

Payments are processed via secure providers. We are not responsible for third-party errors. Late payments may result in cancellation and recovery action.

9. Liability

You participate at your own risk. We are not responsible for personal belongings or indirect losses. Nothing limits liability for death or injury caused by negligence.

10. Events Outside Our Control

We are not responsible for disruption caused by events beyond our control such as weather or travel issues.
